Agnes McCray was born in the Caribbean and moved with her family to Syracuse when she was a child. Agnes says that she is a person with "extraordinary differences" (she has cerebral palsy and uses an electric wheelchair) and is the proud mother of three sons. Agnes received her Associates Degree from Onondaga Community College, her Bachelor's Degree from Geneseo, and her Master's Degree in Special Education and Rehab Counseling from LeMoyne College. Despite her cerebral palsy, Agnes participated on the swim team in high school, and her hobbies in college included skydiving.

Prior to the historic legislation known as the Americans with Disabilities Act, Agnes McCray was a force for change. In 1986, while still a teenager, Agnes was among a group of protestors who chained themselves to Centro buses to demand accessibility. Her involvement in ARISE's Youth on the Move Advocacy group from 1986 to 1991 was just the beginning of an extraordinary life of community action, advocacy, education, and service. She was active during her teen years in other efforts, including the College for Living at Onondaga Community College. At the age of 19, Agnes accepted an invitation to speak at Grant Middle School about being a person with disabilities.

Agnes understands the importance of civic engagement and meets regularly with elected officials. Agnes also knows when more than a meeting is required. During the past 11 years, she has participated in more than 300 protests and advocacy trips. One of those protests (and one of her arrests) involved joining with other activists from around the nation to block every entrance to the Capitol building.

One example of the fruits of her local efforts was passage of the Visitability resolution in Syracuse and Onondaga County. She is now working to get a statewide visitability law passed. Other legislative efforts involve working for passage of the Protection of Income bill, so tenants are not discriminated against based upon their source of income; ADA Title II bill, to ensure access to state and local government (currently only a federal law); and Accessible Taxi bill, to ensure that people with disabilities have access to on demand transportation.

In addition to providing training and guidance for people within the disability community, Agnes makes a difference by training government workers. For the past several years, Agnes has provided training to state workers as well as local workers. She teaches them about the Americans with Disabilities Act and about working with people who have "extraordinary differences". Her training for workers in group homes is a vital part of ensuring that people with physical and intellectual disabilities are protected from abuse. During the trainings, Agnes also offers guidance on making connections in the community for people with disabilities. Her trainings have been videotaped to be used throughout New York State.

Agnes worked for three years to insist upon and secure the appointment of an ADA Coordinator for Onondaga County to assure compliance and to receive and process complaints. In addition to the creation of the coordinator position, she works on a continuing basis to provide training to DSS workers so that they not only comply with the law but understand how best to work with people who have disabilities. As a result of her efforts, Onondaga County is now recognized for the way they do this work.

Many positive outcomes have resulted from Agnes' advocacy work, starting with the decision by Centro to make buses accessible. She has played a vital role in ensuring that people of all abilities are able to exercise their right to vote, and has worked closely with the Board of Elections to address every aspect of the process. Many changes were made in process and in the actual voting machines as a result of her advocacy. On an ongoing basis, she trains election workers on working with people who have disabilities. She is frequently active in voter registration efforts.

Agnes serves on numerous boards, task forces, advisory groups, and her advice is sought by community leaders. She has served on the Mayor's Citizen's Cabinet and was a member of County Executive Mahoney's Education Task Force. Agnes served for five years on the board of the Association of New York State Independent Living Centers and was extremely active in legislative and advocacy on a statewide level. She worked with the Burton Blatt Institute to address disability rights issues, and served on the Board of Directors of Aurora of CNY for 9 years.

Agnes has been active with ARISE since 1986 and has played numerous roles in the organization. She currently serves as President of the Consumer Council and is a member of both the Vice President of the ARISE board of directors and the ARISE Foundation board, and is also a member of the board of HOME Inc., the Syracuse Community Health Center, the Inclusive Emergency Preparedness Task Force and Human Needs Task Force hosted by AccessCNY, the Centro ATAC Committee, and the AURORA Program Advisory Committee.

Agnes' keen intellect, command of complex issues, and tireless efforts have led to a widespread recognition of her as a spokesperson for the disability rights movement in this community and beyond. Agnes has worked to expand the rights of people with disabilities by sharing her time and expertise in extraordinary ways. It is no exaggeration to say that she has spoken on thousands of occasions since then to increase awareness, demand change, and to invite people of all

abilities to become involved. Agnes believes deeply in the right of every person to live a life of independence and choice. She works to create a society that offers everyone the opportunity to fully participate.

Because of Agnes, people with disabilities in Syracuse and Onondaga County have gained greater access to the community. From the decision by Centro to make buses accessible to a visitable ordinance passed in Syracuse that requires all new housing built with public funds to be built with accessible features, she has enriched our community by making sure it is more accessible to all. Agnes talks often about being able to look outside of the box, and has herself been instrumental in making people forget about the box entirely.

Agnes believes deeply in human rights, civil rights, and justice. Whenever there is a situation involving denial of access to rights for whatever reason Agnes will be there to join in the fight.

Serving as emcee of the ADA Celebration in 2012, Agnes spoke about the power of working together.

If you are holding one pencil in your hand, it is easy to snap it in two. But if you have five, seven or ten pencils in your hand, you are not going to break them. She often tells people tough times don't last, but tough people do.

Good afternoon, my name is Elaine Denton and I live in the Town of Manlius.

I wanted to share my thoughts on amending law 3-1996.

First, we have been here before. In 2007 the legislature amended this law to increase the limit of donations to \$10,000 from Friends Groups. It stated that a quarterly written report would be provided to each member of the legislature on March 1, June 1, September 1 and December 1 each year specifying any items that were received during the quarter. Have any of you received these quarterly reports? If not, I would wait on passing further changes on donations until current law is followed.

Secondly, section 2 of this proposed law states the County is in the process of selling the naming rights. But in 2017, Comptroller Antonacci sent a letter to the legislature with concerns and recommendations that this body should be involved and approve naming agreements. To quote from this letter "The power of municipalities to name a building for pecuniary gain is questionable. What is absolutely clear is the power to name a building is a power for the legislative body of a municipality. Presently, there is no authority for the County Executive to contract such power away, much less undertake it independent of the Legislature." Yet this proposed law acknowledges that the county is working on this once again with no checks and balances provided by the legislature.

Lastly, for the County to be focused on filling a \$10 million dollar funding gap for an expensive aquarium during a time when residents are losing their jobs, costs are rising and people can't afford basic needs is shameful. Nonprofits, governments, schools and more may be losing critical federal funding but here is Onondaga County doing everything they can to build an aquarium.

Destiny, the amphitheater, Amazon, all sold to us that they would bring jobs and economic benefits to Onondaga County. Yet here we are with the same problems we have had. I ask you again to stop this project. Take the loss now, and turn it into a positive for our community by investing in housing, transportation and let's get rid of the lead in our community.

## LOCAL LAW NO. 10 -2007

A LOCAL LAW AMENDING LOCAL LAW 3-1996 TO ESTABLISH A VALUE UP TO \$10,000  
FOR GIFTS, CONTRIBUTIONS AND DONATIONS FROM FRIENDS GROUPSBE IT ENACTED BY THE ONONDAGA COUNTY LEGISLATURE OF THE COUNTY  
OF ONONDAGA, NEW YORK, AS FOLLOWS:

Section 1. Friends organizations exist to enhance and support the operations of various County Parks. (Friends of Carpenter's Brook Fish Hatchery, Friends of Beaver Lake, Inc., Friends of the Zoo and Friends of Historic Onondaga Lake)

Section 2. Pursuant to Local Law No. 3-1996, gifts, contributions and donations with a value over \$1,500 must be accepted by resolution.

Section 3. It is the desire of this Legislature to allow for gifts, contributions, or donations from the above referenced friend's groups, up to a value of ten thousand dollars (\$10,000), to be accepted without further action by this Legislature.

Section 4. This Legislature hereby authorizes the Chief Fiscal Officer of Onondaga County to accept, from the above referenced friend's groups, property, donations or contributions as gifts for lawful county purposes, worth no more than ten thousand (\$10,000) dollars, on behalf of Onondaga County, without further action by this Legislature.

Section 5. This Legislature hereby authorizes the Comptroller of Onondaga County to adjust the County Budget to account for the receipt of such gifts, contributions or donations.

Section 6. The Chief Fiscal Officer, upon acceptance of such a gift, contribution or donation, shall notify the Chair of the Onondaga County Legislature and the Chair of the appropriate committee or committees of such legislature. In addition, a quarterly written report shall be provided to each member of the legislature on March 1, June 1, September 1 and December 1 of each year specifying any items that were received during the quarter immediately preceding such report.

Section 7. Nothing contained herein shall be construed as precluding the Onondaga County Legislature from accepting or refusing to accept by gift any property or monetary contribution valued at less than ten thousand dollars (\$10,000).

Section 8. This Local Law shall supersede Local Law 3-1996 to the extent necessary to allow the gifts authorized herein but otherwise Local Law 3-1996 shall remain in full force and effect.

Section 9. This Local Law shall take effect upon filing, and pursuant to the provisions of Municipal Home Rule Law.

**Re: Onondaga County Lakeview Amphitheater Naming Rights**

Dear Legislators:

A recent news article published online discussed naming rights at the Onondaga County Lakeview Amphitheater.<sup>1</sup> As of this writing, we are awaiting contract information which we were forced to subpoena, therefore, our comments today will be limited to information made public so far.

Of immediate concern is the last paragraph in the article which states:

“[Deputy County Executive William] Fisher said there is no bidding process or publication for sponsorship deals, since they are negotiated by the county's agent, SMG. A deal would not require approval from the legislature, he said.”

I respectfully disagree with Mr. Fisher's estimate that no bidding process or other publication process is required for sponsorship deals relating to County-owned property. I further disagree that approval by the Legislature is not needed.

In 2012, this Office released its audit report concerning naming rights of County property.<sup>2</sup> At that time, we highlighted the fact the Legislature had previously acted on revenue contracts, such as naming rights agreements, by way of Resolutions 241 & 310 of 2010. We also highlighted Local Law 3-1996, as amended, which requires any charitable donation in excess of \$1,500 to be approved by the Legislature.

Our report also noted under Resolutions 398-200 the Legislature set forth a process and standard for the naming of buildings. Under Resolution 398-200, there are six requirements:

- 1) The building will be named for an individual who has had a long-term impact and service to the community;
- 2) The individual should be, or have been, a resident of Onondaga County;
- 3) The naming of the building need not be done posthumously;
- 4) The cost of signage for the building(s) shall be the responsibility of Onondaga County;
- 5) After a recommendation has been made and passed through committee, it will be voted on by the full Legislature, and the affirmative vote of two-thirds of the whole Legislature shall be required to adopt said recommendation;
- 6) Court Houses shall not be subject to any naming.


Resolution 398-2000 goes on to say “the foregoing criteria shall not apply in those instances where there is an opportunity for corporate naming rights”. It does not appear there are any other acts by the Legislature on this topic.

New York State Law does speak on this topic. County Law §215(3) provides, among other things, “Such buildings may be named, maintained and kept in repair, furnished and equipped for such public purposes.” This power is the legislative body’s power to exercise. Of more interest is a proposed law referenced in our 2012 report. Senate Bill S4324A-2011 would have allowed municipalities to lease naming rights of government owned property. This Bill has not been passed and has been reintroduced every State Legislative Session. Senate Bill S1945 is pending in a Senate Committee, while a similar bill, Senate Bill S3865, has advanced to a third reading as of March 13, 2017. The pending legislation in the Senate reveals a belief municipalities do not currently have the power to lease naming rights.

The power of municipalities to name a building for pecuniary gain is questionable. What is absolutely clear is the power to name a building is a power for the legislative body of a municipality. Presently, there is no authority for the County Executive to contract such power away, much less undertake it independent of the Legislature. At a minimum, the Legislature must review for itself the contracts concerning the Lakeview Amphitheater and determine, as the policy determining and governing body of the County<sup>3</sup>, whether the leasing of naming rights at the Onondaga Lakeview Amphitheater is in the best interests of Onondaga County.

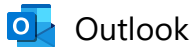

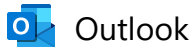

A RESOLUTION AUTHORIZING RENOVATIONS TO THE COUNTY CLERK'S OFFICE IN AND FOR THE COUNTY OF ONONDAGA, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$500,000, AND AUTHORIZING THE ISSUANCE OF \$500,000 BONDS OF SAID COUNTY TO PAY COSTS THEREOF

BE IT RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the County Legislature of the County of Onondaga, New York, as follows:

Section 1. Renovations to the County Clerk's Office, including costs incidental thereto, is hereby authorized in and for the County of Onondaga, New York, at a maximum estimated cost of \$500,000.

Section 2. The plan for the financing thereof is by the issuance of \$500,000 bonds of said County, hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is twenty-five years pursuant to subdivision 12(a)(1) of paragraph a of Section 11.00 of the Local Finance Law.

Section 4. The faith and credit of said County of Onondaga, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. To the extent not available from other sources, there shall annually be levied on all the taxable real property of said County a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of such notes, is hereby delegated to the Chief Fiscal Officer of such County. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Chief Fiscal Officer, consistent with the provisions of the Local Finance Law.

Section 6. All other matters except as provided herein relating to the bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue bonds with substantially level or declining annual debt service, shall be determined by the Chief Fiscal Officer, the chief fiscal officer of such County. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Chief Fiscal Officer shall determine consistent with the provisions of the Local Finance Law.

Section 7. The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said County is not authorized to expend money, or

- 2) The provisions of law which should be complied with the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
- 3) Such obligations are authorized in violation of the provisions of the Constitution.

Section 8. The County Executive is authorized to enter into contracts to implement the intent of this resolution. In the event that General Fund Operating Surplus Funds are available at the end of the fiscal year, and if the Chief Fiscal Officer of Onondaga County deems it fiscally advantageous to use surplus funds rather than borrowing, all or a portion of the cost of the improvements authorized herein shall be paid using such surplus funds. Further, in the event that General Fund Operating Surplus Funds are so utilized, then the authorization to issue bonds provided within this resolution is hereby rescinded accordingly, reduced by the amount of funds utilized.



LOCAL LAW NO. A - 2025

A LOCAL LAW AUTHORIZING THE SALE OF COUNTY PROPERTY LOCATED IN THE TOWN  
OF CLAY

BE IT ENACTED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ONONDAGA,  
AS FOLLOWS:

Section 1. Findings. The County of Onondaga is the owner of two adjacent parcels of land located at 4487 Buckley Road and Morgan Road in the Town of Clay, bearing Tax Map Nos. 087.-01-29.0 and 087.-01-40.1 and comprising 26.56 ± total acres (the “Property”). In accordance with the terms of a July 5, 2022 Option to Purchase agreement between the County of Onondaga and VIP Development Associates, Inc., which option was subsequently assigned to VIP Clay Holdings, LLC, VIP Clay Holdings, LLC timely exercised its option to purchase the Property for a total consideration of \$1,300,000.00, inclusive of a non-refundable \$125,000.00 deposit. An appraisal of said Property was obtained, and such consideration is equal to or in excess of the appraised value. Said property is not needed for County purposes.

Section 2. Environmental Review. An analysis of the potential environmental impacts, if any, has been done under the State Environmental Quality Review Act (SEQRA) and, as lead agency, the County hereby determines that the proposed action is an Unlisted Action under SEQRA and a Short Environmental Assessment Form has been prepared. The Short Environmental Assessment Form filed with this Legislature is satisfactory with respect to scope and content and adequacy in compliance with SEQRA and is hereby accepted by the County. Onondaga County does hereby make and adopt a Negative Declaration for the project, and has determined that the proposed action will not have a significant effect on the environment. The Onondaga County Executive, or his designee, is authorized to take such action to comply with the requirements of SEQRA, including without limitation, the execution of documentation and filing of same and any other actions to implement the intent of this local law.

Section 3. Sale Authorized. The County Executive is hereby authorized to transfer to VIP Clay Holdings, LLC said Property located in the Town of Clay for a total consideration of \$1,300,000.00. The County Executive is hereby authorized to execute agreements to further the intent of this local law.

Section 4. Effective Date. This local law shall be filed and take effect in accordance with provisions of the Municipal Home Rule Law, subject to a permissive referendum.

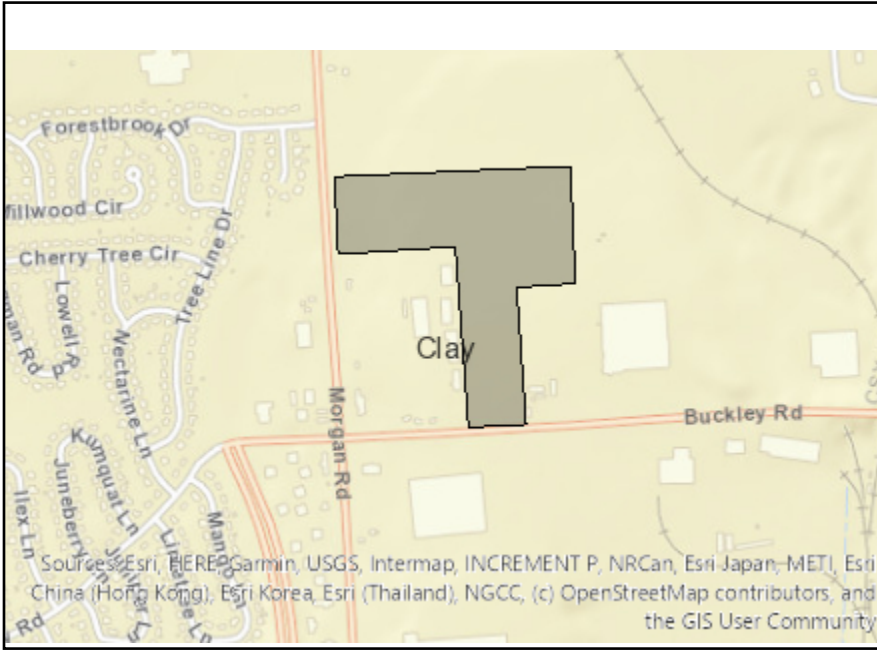

LOCAL LAW NO. B - 2025

A LOCAL LAW AMENDING LOCAL LAW NO. 3-1996 TO AUTHORIZE ONONDAGA COUNTY TO ACCEPT AND APPROPRIATE GIFTS, CONTRIBUTIONS AND DONATIONS FOR THE AQUARIUM

BE IT ENACTED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ONONDAGA, AS FOLLOWS:

Section 1. Onondaga County is constructing, and will own, a public Aquarium located along the Inner Harbor, and this Legislature recognizes and understands that individuals, corporations and other entities may wish to financially support the cost of building said Aquarium and its various exhibits.

Section 2. The County is in the process of finalizing a sponsorship program that has a name-in-title component and securing donations, gifts and/or contributions (collectively, "donations") in support of said Aquarium.

Section 3. The Legislature appropriated \$85,434,751 for the purpose of constructing said Aquarium pursuant to Resolution No. 119-2022 and, except with respect to donations authorized hereunder, does not intend, presently or in the future, to appropriate any additional funds for the Aquarium project.

Section 4. Pursuant to Local Law No. 3-1996, donations with a value over \$1,500 must be accepted by resolution.

Section 5. This Legislature hereby authorizes the Chief Fiscal Officer of Onondaga County to accept, and appropriate, donations to the Aquarium project as gifts for lawful county purposes, on behalf of Onondaga County, without further action by this Legislature.

Section 6. This Legislature hereby authorizes the Comptroller of Onondaga County to adjust the County Budget to account for the receipt of such donations.

Section 7. The Chief Fiscal Officer shall provide to the Legislature a quarterly written report quantifying all such donations received.

Section 8. This Local Law shall supersede Local Law No. 3-1996 to the extent inconsistent herewith, but otherwise Local Law No. 3-1996 shall remain in full force and effect.

Section 9. This Local Law shall take effect upon filing, and pursuant to the provisions of Municipal Home Rule Law.
