WAYS & MEANS COMMITTEE MINUTES – JANUARY 30, 2024 COLLEEN A. GUNNIP, CHAIR

MEMBERS PRESENT: Mr. May, Ms. Abbott, Mr. Romeo, Mr. Ryan, Mr. Knapp, Mr. Garland ALSO ATTENDING: Chairman Burtis, Mr. Meaker, Ms. Palmer, Mr. McCarron, Mr. Brown; also see attached

Chair Gunnip called the meeting to order at 10:34 a.m., and the previous meeting's minutes were approved.

1. APPOINTMENTS:

a. Confirming Appointments to the Onondaga County Fire Advisory Board (William Murphy, James Perrin, James Rolince, Douglas Bloodgood, Sean Doolittle, Steven Dembowski) (Sponsored by Mr. Olson)

Mr. Knapp requested to be a cosponsor.

A motion was made by Mr. Knapp, seconded by Mr. May, to approve this item. Passed unanimously; MOTION CARRIED.

b. Appointing Two Directors to the Onondaga County Tobacco Asset Securitization Corporation (Colleen Gunnip, Richard McCarron) (Sponsored by Mr. Burtis)

A motion was made by Mr. Knapp, seconded by Mr. May, to approve this item. Passed unanimously; MOTION CARRIED.

c. Confirming Reappointments to the Cornell Cooperative Extension Association of Onondaga County Board of Directors (Debra Cody, Charles Garland) (Sponsored by Mr. Burtis)

A motion was made by Mr. Knapp, seconded by Ms. Abbott, to approve this item. Passed unanimously; MOTION CARRIED.

d. Confirming Appointment to the Onondaga County Jury Board (Richard McCarron) (Sponsored by Mr. Burtis)

A motion was made by Mr. Knapp, seconded by Mr. May, to approve this item. Passed unanimously; MOTION CARRIED.

2. FACILITIES MANAGEMENT: Archie Wixson, Commissioner

- a. BOND: A Resolution Authorizing Reconstruction of the Community Plaza Garage Floor in and for the County of Onondaga, New York, at a Maximum Estimated Cost of \$2,450,000, and Authorizing the Issuance of \$2,450,000 Bonds of Said County to Pay Costs Thereof (\$2,450,000) (Sponsored by Ms. Cody)
- Resurfacing and restoration of floor of Everson Garage; been on the table for years, but stalled for various reasons
- Facilities will be responsible for arranging alternate parking

- Full design completed and still sufficient
- Milling of top 2-3", restoration of reinforcement in slab, replacement of vault covers for sewer lift stations, and resurfacing with fresh concrete and sealing

Questions/Comments from the committee:

- Will Facilities be pursuing accessibility in the garage?
 - o Offered to take a look at altering the stairs to a ramp if it has the right ADA sloping
 - o If it does not, possibly zigzag to ramping
 - o Will look into it, not a big cost, and if it is reasonable and feasible, no objection to doing it
 - o Does not change design or cost of resurfacing the main floor
- Are the stairs (going outside) that were closed last month included?
 - o No, they were restored in 2015
 - o It was closed due to oil spilled in there; overwhelming odor that has now dissipated
- Who will be doing the work? Will it go to bid?
 - o It will go out to regular public bid for this work

A motion was made by Mr. Knapp, seconded by Mr. May, to approve this item. Passed unanimously; MOTION CARRIED.

- b. BOND: A Resolution Authorizing Courthouse HVAC Renovations in and for the County of Onondaga, New York, at a Maximum Estimated Cost of \$3,000,000, and Authorizing the Issuance of \$2,000,000 Bonds of Said County to Pay Costs Thereof (\$2,000,000) (Sponsored by Ms. Cody)
- Next step in HVAC rehab in this building (court house)
- In process of wrapping up work authorized last year, which includes radiant fin tube perimeter heat on 1st and 4th floor
- Asking to release \$2M to continue next phase; same work and taking another couple floors

A motion was made by Mr. May to approve this item.

Questions/Comments from the committee:

- Was Danforth awarded the previous phase bid?
 - Yes, Danforth is the contractor successful in doing work; JW Danforth
- Has Danforth subbed any of the work out?
 - o Have portion of the work subbed out in participation of minority and women's goals; did submit plan
- Will this go to bid again, or is there an existing contract?
 - Have the choice to make; when see completeness of work, may make sense to continue through IPA available, or can go out to street for competitor bids
 - o May have to do with market; will not pursue till later this spring
- Is "spring" based on supplies and materials, is it for a better price, or can Facilities wait?
 - o Strategies that make using program more economical
 - o There are big projects out on the street currently

REQUEST: Follow up with the Legislature on whether it will be rebid or not

Mr. Knapp seconded the motion made by Mr. May.

- How is Facilities reaching out to minority contractors and sharing?
 - o In all projects, onus on contractor to do reach out
 - o Contractors must go into market and solicit capable minority and women contractors to support 30% goals
 - o Office of Diversity always available to assist and offer contractors interested in types of work
 - Office of Diversity comes to every pre-bid conference; rely on them to share list of contractors and networking

- Bidding/purchasing processes have received investments overtime to automate and make information accessible to everyone; quite sophisticated
 - o A proposing contractor can look up information; there are online lists and networking; rely on Office of Diversity to do that for the contractor

A vote was taken on the resolution. *Passed unanimously; MOTION CARRIED*.

- c. BOND: A Resolution Authorizing Improvements to the Eric Canal Museum in and for the County of Onondaga, New York, at a Maximum Estimated Cost of \$1,300,000, and Authorizing the Issuance of \$1,300,000 Bonds of Said County to Pay Costs Thereof (\$1,300,000) (Sponsored by Ms. Cody)
- Last year spent time reviewing a condition assessment, feasibility study and recommendations from a firm engaged by Erie Canal Museum
- Documents identified important investments the museum needs to maintain the museum, integrity of building, and appearance to public initial improvements came to \$1.3M
- Report is available if anyone wants to read it
- Taking recommendation of expert and investing asset protection

A motion was made by Mr. May, seconded by Mr. Knapp, to approve this item. Passed unanimously; MOTION CARRIED.

- d. BOND: A Resolution Authorizing War Memorial Upgrades in and for the County of Onondaga, New York, at a Maximum Estimated Cost of \$5,210,000, and Authorizing the Issuance of \$5,210,000 Bonds of Said County to Pay Costs Thereof (\$5,210,000) (Sponsored by Ms. Cody)
- Replace telescopic seating in lower seating bowl of War Memorial and make improvements to sound system
- Majority of cost is seating
 - o Seating has 15 year useful life and was installed in 2009, finished in 2010
 - o Now problematic and difficult to retract and deploy
 - o Several attempts at repair and restoration, but only band aids to system; asking for funding to replace
 - o Replacing majority with fixed seating
 - o Able to do fixed, because some configurations previously done that needed retractable seating, no longer do
 - Only need retraction in 4 sections; rest will be fixed seating
- Down time for events
 - o Certainly will not be able to have events during construction of seating
 - Will work with ASM to determine target for construction
 - o It is possible it will need to be phased to not inconvenience any clients
 - o Will do work during summer season; (i.e.) almost impossible do with hockey season

A motion was made by Mr. Knapp, seconded by Ms. Abbott, to approve this item. Passed unanimously; MOTION CARRIED.

- 3. PARKS & RECREATION: Brian Kelley, Commissioner
 - a. BOND: A Resolution Authorizing Improvements to Various Parks in and for the County of Onondaga, New York, at a Maximum Estimated Cost of \$1,935,000, and Authorizing the Issuance of \$1,935,000 Bonds of Said County to Pay Costs Thereof (\$1,935,000) (Sponsored by Ms. Cody)
- Yearly ask for preventative maintenance, safety concerns and infrastructure
- Public in direct contact with Park's infrastructure daily the safer and better can keep it, the better program to public
- Gives flexibility in emergency situations to be able to pivot
- Projects cut and dry; essential to the facilities

A motion was made by Mr. May, seconded by Mr. Knapp, to approve this item. Passed unanimously; MOTION CARRIED.

- b. BOND: A Resolution Authorizing Onondaga Lake Park Marina Expansion and Rehabilitation in and for the County of Onondaga, New York, at a Maximum Estimated Cost of \$13,700,000, and Authorizing the Issuance of \$13,700,000 Bonds of Said County to Pay Costs Thereof (\$13,700,000) (Sponsored by Ms. Cody)
- Onondaga Lake Park (OLP) Mariana expansion and rehabilitation
- Current OLP Marina will be renovated and expanded
 - o Retaining wall replacement
 - Addition of short term dockage
 - Expanded parking
 - O Additional utility enhancements lighting, water and power
 - o Additional dredging to return marina back to original depths original depth of marina was 8' and now at 6'
- Original wall portion in CIP since 2022 last year authorized to do engineering study
 - o Wall is failing, buckling; original from 1930's
 - o 26 boats hook to front of this wall, which is in bad shape
 - o Wall is the infrastructure to hold everything in place
- Have ability to expand marina within current footprint
 - o Currently have 100 slips, and this project will bring it to 140 slips
 - o Key point is transient use want to get more folks to the park
 - Creating (i.e.) 25 transient slips allows people to tie off, use the park, visit the village businesses, restaurants, can rent kayaks, fish, use pickle ball courts
 - o Opens new possibility of folks coming to park and will have an economic impact on the village
- Marina footprint will not change and Park's will use same staff can do with 1 fulltime and 2 part-time employees
- Maintenance program will stay the same for OLP
- Need to fix the wall; if not, it will fail and 26 boats will have issues

Questions/Comments from the committee:

- What will be the entrance fee for the daily slip use?
 - o Currently to launch is \$10
 - o For a slip with utilities is \$40/foot; \$35/foot without utilities
 - o Minimum charge of \$1,146 for boats with utilities and \$690 for boats without utilities
 - Well below the market
- What if someone wants to come for the day?
 - O Still discussing, but good opportunity that there may be no charge
 - o Pull up, tie off and walk village; transient spots kayaks, canoes, fishing boats
 - o Big boats, similar to Skaneateles, may stay 3 hours, then charge after that
- Are there lake stewards, in terms of bringing in boats that travel to different lakes and potentially bringing in invasive species?
 - o Park's has boxes for invasive species that people can drop stuff in; will look at it closer
 - O Do not have boat washing station, but it is something that could be added in the future
- Have had issues with invasive species, so it would be a good idea based on the investments being made
 - o Yes
- When would the county start to realize the return on investment for this project?
 - Able to have conversation with Visit Syracuse, who will be able to do deeper dive once they start collecting data
 - o (i.e.) if there are 25 spots, and maybe 20 are full for transient use, with boats holding an average of 3 people and half of those boats will spend the night; probably estimate \$300,000 annually
 - o Big impact would be fuel; food, shopping and overnights are about \$100,000
 - o CVB is interested in project; after first year will have better means to track where people went
 - o Will hand out surveys and get information from dedicated staff at Marina
 - o Power gives people the opportunity to stay overnight; part of transient may be offered
 - One of County Executive's big initiatives was not only day use, but allowing people to stay the night

- Suggestion to get a boat and shuttle people to and from amphitheater
 - o Park's has been approached by someone and is in talks currently about it
- This is a renovation of the Marina; support the project, but would have liked to see more about sustainability, investments in blueways and greenways, and plans to make Marina more of a focal point
 - o More to talk about with future possibilities; agree 100%; potential there, but does not start until they fix the wall
 - o Do not think they are at that point yet; will fix the wall and get dockage, then reach out and survey people

A motion was made by Mr. May to approve this item.

- Are all the slips rented out every summer?
 - o Yes, 100%
- Does the administration fee include engineering design, contingencies, construction, inspection, permitting?
 - Yes and escalators
- When is the start date for this?
 - o People can be in Marina from April October
 - o Hope to do engineering and feasibility study now, then begin construction in October
 - o Come April will be ready to go; no displacement
- If construction starts in October, would the county bond for it then in hopes the permitting would be provided in a reasonable amount of time?
 - o Finance:
 - With CIP, typically county has ability, especially now, to advance projects with cash on hand
 - Process is to then evaluate and assess the project with the department on where it is, what has been spent to date, and what they anticipate spending; borrow on the backend
 - Not over borrowing and getting into negative arbitrage situations
 - Until the day changes when county does not have ability to float that, that will be the approach
 - Parks
 - As soon as start design and engineering, will submit for the permitting
 - It is a maintenance drudging permit, which typically takes 6-8 months through DEC; will work with agencies to get the permits
 - Cannot start construction or anything until they get those
- Has Park's reached out to Inner Harbor to make it more accessible? Channel gets shallow and needs to be dredged
 - o Conversation is coming; realize that OLP Marina will be the only one on lake with access to aquarium
 - o After construction of aquarium, will have places for boats to tie off
 - o Channel is very low; people at Inner Harbor are creating access too; there is a kayak launch at Meyers Creek

Mr. Knapp seconded the motion made by Mr. May. Passed unanimously; MOTION CARRIED.

- 4. WATER ENVIRONMENT PROTECTION: Shannon Harty, Commissioner
 - a. A Resolution Approving Improvements for the Onondaga County Sanitary District in and for the County of Onondaga, New York (Sponsored by Ms. Abbott)
 - b. BOND: A Resolution Authorizing the Issuance of \$55,945,000 Bonds of the County of Onondaga, New York, to Pay Costs of Certain Improvements for the Onondaga County Sanitary District in and for Said County (\$55,945,000) (Sponsored by Ms. Abbott)
- 5 projects 4 listed on authorization resolution, 5 listed on bond resolution
 - o Camillus Force Main replacement rehabilitation phase 2
 - Conveys most of west side Metro WWTP service area; Camillus to West Side Pump Station
 - Started phase 1 approximately 5 years ago; did not dig pipes up, but pulled liner through them
 - Tested on first 1/3 of the pipeline and went very well
 - Looking for authorization for \$25M to complete last 2/3 of project

Did SEQR review, Type 1 action; recommending negative declaration

Comprehensive projects

- Projects at each of the 6 WWTPs, and some conveyance
- Looking for \$625,000 for miscellaneous improvements at Metro WWTP on Hiawatha Boulevard
- Rehabilitations are Type 2 action; not subject to SEQR review

West Entry Pump Station

- On bond resolution, but not seeking authorization at this time
- Within sewer consolidation projects; investments related to any assets taking over long term lease agreements
- First major capital investment in Baldwinsville-Seneca Knolls service area, northern end of collection system
- Serves industrial area with several large food manufacturers
- Current pump station discharges through residential neighborhood
- Will rehab entire facility and build new force main to bypass wastewater around neighborhood to trunk sewer
- Will get to treatment plant faster, eliminate some collection system odor issues as well
- Type 1 action and going through SEQR review
- Not in position to make SEQR determination; will come back next month to move forward

Wastewater Treatment Transportation project

- Get funding for all of the assets owned by county; larger pump stations and trunk sewers
- Seeking authorization for rehabilitating 3 pump stations located in city of Syracuse within conveyance:
 Richmond Street, Sacket Street and Taylor Street Pump Stations
- \$1.8M; Type 2 action (rehabilitating existing), no SEQR required

White Pine Rt 31 Pump Station

- Started project in 2020 for \$1.6M to start engineering
- Started initial concept and authorization in 2022 for \$16M
- Based on small service area immediately adjacent to Route 31 Caughdenoy Corridor
- Involved small pump station and single force main routed along MWB right-of-way
- When in detail/design review; engineers looked at how far sewers would need to be expanded and come up with a more comprehensive plan for what the pump station will need to be for the future
- Now looking at larger pump station with 2 force mains and a longer route
- Cannot use MWB; need to preserve right-of-way for utilities; have new right-of-way and easement going along Caughdenoy Road, Van Hoesen Road and using existing County right-of-ways to get to Oak Orchard WWTP
- Establishment of municipal sewer systems to support what is coming to community
- Micron will probably use about 2M gallons of capacity; other 3M gallons/day will be preserved for entire service area with expansion between Clay and Cicero
- Will allow for flexibility to move flows between Brewerton WWTP and Oak Orchard WWTP service areas
- Changed scope and looking at comprehensive solution long term seeking additional \$19M
- Completed SEOR; Type 1 action; recommending negative declaration

Questions/Comments from the committee:

- West Entry Pump Station does not have project authorization, but asking for bonding. How does this process work with bonding first before project authorization?
 - o Law:
 - Realized that the West Entry Pump Station would take longer
 - SEQR mandates before taking final action to internally approve, last step needed is completed SEQR
 - 2 resolutions for WEP; first being Article 11a approval, then bond resolution to finance approved project
 - Could come back with standalone bond resolution for West End, but it was already prepared by Bond Counsel
 as a joint package
 - Made sense to have a standalone for the authorization, but keep the bonding as is, knowing the county would not go to bond until doing the work
- It also gives the county the ability to shop at a higher scale for borrowing more money
 - o Law:
 - Yes; Legislature still has approval authority

- What is the difference? Does it save money by doing this?
 - o Law
 - Do believe that when the county packages bonds together and hit bond market, do get added value
 - Finance:
 - At this time, packaging of projects together is different issue than issuing bonds
 - Not necessarily a benefit to approach doing here to the market and rate receiving
 - County will borrow money based on status of projects
 - Approach here is to keep things moving along and work on necessary environmental aspects of project
 - Will have to come back for approval by the Legislature
 - Those 2 are not related; not going out tomorrow and issuing \$55M of bonds; some could qualify for EFC financing as well
- WEP will come back for SEQR authorization?
 - Yes
- Where is the county on bonding with WEP in regard to limits?
 - o WEP:
 - Right now, have decent backlog of borrowing
 - Currently ~\$300M in authorized and available to WEP
 - Working with Finance to close out bonds, as they are older projects and WEP is not accessing the borrowing
 - Have met with Finance about long term placement, cost recovery and managing the fund
 - Finance:
 - Lot of work that WEP is undertaking
 - Long term projection, 2024-2029 CIP and map out scheduled, authorized and proposed debt will see spike in sewer fund in 2026 2032/2033
 - Includes this work, continued work required for sewer consolidation, and all infrastructure assets need to maintain at highest level
 - From a funding perspective, will work with Commissioner and WEP staff to responsibility approach funding of projects at a sustainable rate to taxpayers and users
 - Draw down on fund balance where necessary
 - Continued eye towards operational efficiencies to control operational costs where possible
 - Long term strategy will continue to use, so the county is not rate shocking community
 - o WEP:
 - 2024 budget did include cash funds for cost recovery study; will bring in consultants to start analyzing the revenue streams and how they need to be adjusted in the future
- Over the last 2 years, there has been 5-6 authorized projects each year; where does WEP stand with these? Is this something WEP can work with Chair Abbott on to get an update at the Environmental Protection Committee?
 - Yes; can do a CIP update for Legislators
- What is status of the other consolidation projects? Is WEP talking with the other districts on consolidation?
 - Yes; seeing benefits of it
 - o Lot of different strategies coming, so it has slowed down
 - o As time allows, will look at next service areas
- Will this be it for White Pine, or will there be more?
 - o For conveyance system, pretty confident at 100% design with consultants
 - o Have all the detailed soil studies, looked at hydraulics, met with DEC
 - In early years, maintaining velocity in the pipelines is very important, which is why they need to start with a smaller pipe; as the system grows, the velocities will be too big and will drive the second pipe
 - o Confident WEP is in good spot to have flexibility and good use of rate payer money; good construction estimates
- Will there be more improvements at Oak Orchard and Brewerton Road?
 - Yes; this is initial expansion of municipal sewer system
 - o Did receive authorization for \$30M to start on municipal treatment plants and upgrades
 - o Completely separate from industrial; focusing on municipal system upgrades

- Will the committee be updated on the fund balance in the district in the next couple months?
 - o Finance:
 - Yes, when coming for first quarter forecast, will give updates on fund balance
 - Believe in high 20's to low \$30M range (as of end of 2022 with operations yet to be determined for 2023)
 - Working on closing 2023 books
- Chair request for status report on projects in EP a good idea; should include financial accounting on what was authorized, what has been spent, and what is forecasted to be spent
 - Will do best to boil it down

A motion was made by Ms. Abbott, seconded by Mr. May, to approve this item. Passed unanimously; MOTION CARRIED.

5. **COUNTY LEGISLATURE**: Legislator Brian May

- a. Providing for a One Year Moratorium on the Disposition of the Jamesville Correctional Facility (Sponsored by Mr. May)
- Resolution referred to as meaningless, which could not be further from truth
- Step this body took with decision made a year ago was practical
- Debate over whether or not to make the main decision, but not a lot of debate to make this practical step
- Too many moving parts and competing interests that would make this a challenging process
- Put Legislature's stance into record with ability to renew it; considerate decision of circumstances
- Legislature year over year has proven support of public safety section of Onondaga County government
- Public safety is the largest consumer of local dollars generated by taxes and fees
- Every single year there is a request for vests, training or cars; whatever is offered, this body does more every time
- Resolution validates commitment
- Renewing it, not because of rumors of sale, but just do one thing at a time
- Know what the goals were back then, and committed to those goals

Questions/Comments from the committee:

• Echo that; every year the legislature does more; public safety matters and will support this

Mr. Ryan requested to be a cosponsor.

- Are there any updates on lawsuits involving the penitentiary?
 - o Law:
 - This relates to jail, but as far as jail litigation, it is scheduled on the 8th; will know more with that decision
- It says one year; is there a date?
 - o Law:
 - One year from date here of

A motion was made by Mr. May, seconded by Mr. Ryan, to approve this item. Passed unanimously; MOTION CARRIED.

- **6. FINANCE:** Donald Weber, Director of Real Property Tax
 - a. Approving and Directing the Correction of Certain Errors on Tax Bills
- First in Clay unpaid water charge; second clerical error made by assessor
- Manlius error by assessor to grant exemption to NYS
- Skaneateles failure to make village owned property exempt
- Van Buren town error in levy of water district tax; had to correct town water district charges
- 3 at bottom sewer unit charges
 - o First is \$340,000 clerical error for residential users, who are supposed to be charged 1 unit per parcel; some were inadvertently charged by water consumption

- Recognized quickly and corrected
- Last 2 are various commercial users based on water consumption
 - o Some users inquired about how the units were calculated; after investigation by WEP, those needed to be corrected

Questions/Comments from the committee:

- How does the county calculate water usage in coordination with a village or town? How do they know it is accurate, and people are paying for the water they are using?
 - o WEP:
 - Rely on local water purveyors to turn over their water meter data, which includes OCWA, town of DeWitt, town of Clay, and village of Baldwinsville
 - City of Syracuse is its own water purveyor, maintains their water meter data and their water use assessments
 - 1. Collecting water data on commercial and industrial properties for 12 calendar months
 - 2. Match to tax parcels to correct accounts
 - 3. Take total amount for the year and divide by 105,000 gallons, which becomes a sewer unit assessment
 - Challenging process with about 104,000 parcels in CSD outside city that have to be assessed under county tax bill process; ~4,000 are commercial or industrial, which are assessed on water data
 - Lot of data collection and analysis; success rate is approaching 99%
- \$342K clerical error; is this a thorough result, is there more to come, and how much of the problem has been addressed?
 - o Finance:
 - Most done; know where the shortfalls are
 - Most tend to be clerical errors, not problems with the process
 - Meeting regularly about process, because it is complex
 - Seeing more errors now, because they are being more proactive in fixing process
 - Previously things stayed the same and did not see as many errors
- (i.e.) If someone says their bill does not look right, can legislators say the matter has been addressed?
 - o Finance:
 - Yes, WEP got website up in record time
 - o WEP:
 - Learned the struggle of getting the information out and educating the taxpayers on what the various charges are
 - In December, noticed WEP needed central point to file inquiry, so set up website
 - Sent out to local assessors, because when someone has a question on tax bill, they will most likely go to tax assessor first
 - Assessors knew if it was related to that charge, they could send person to WEP
 - Lot of people did not know what the charge was; good to get ahead and address quickly

A motion was made by Mr. Ryan, seconded by Mr. May, to approve this item. Passed unanimously; MOTION CARRIED.

7. LAW:

a. Settlement of Actions

Mr. Yaus stated for the record, "legislators, the resolution you are to consider concerns proposed litigation, so I would therefore recommend such be discussed in Executive Session."

Ms. Abbott made a motion, seconded by Mr. May, to go into executive session for the purpose of discussing proposed, pending or current litigation. Passed unanimously; MOTION CARRIED.

A motion was made by Mr. Knapp, seconded by Mr. May, to exit executive session. Passed unanimously; MOTION CARRIED.

Chair Gunnip stated for the record, "no motions or actions were taken during executive session."

Mr. Ryan discussed wanting to do a local law to amend the County Charter to change certain language in regard to apprenticeships with county projects and to have it be considered at Ways and Means.

A motion was made by Chair Gunnip, seconded by Ms. Abbott, to adjourn the meeting. Passed unanimously; **MOTION CARRIED.**
