WAYS & MEANS COMMITTEE MINUTES – NOVEMBER 28, 2023 BRIAN F. MAY, CHAIR

MEMBERS PRESENT: Mr. Ryan, Mr. Burtis, Ms. Abbott, Mr. Knapp

MEMBERS ABSENT: Mr. Kinne, Mrs. Ervin

Chair May called the meeting to order at 11:41 a.m., and the previous meeting's minutes were approved.

- 1. EMERGENCY MANAGEMENT: Daniel Wears, Commissioner
 - a. Amending the 2023 County Budget to Accept Grant Funds from the Federal Department of Transportation for the County Department of Emergency Management to Develop and Implement Plans for Improved Preparation and Reports Concerning Hazardous Materials Incidents Involving Pipelines (\$121,000) (Sponsored by Mr. Olson)
- Receive grant money from US DOT
- Pipeline emergency response grant, on behalf of Onondaga, Madison, Oswego counties and city of Syracuse
 - Worked together on application
- Purpose of grant to hire contractor to design and conduct table top exercises related to hazmat incidents involving pipelines in each one of the partnering counties; all part of Regional Hazardous Response Team
- Team will be involved in scope of work before it goes to RFP; about 1 year or so to get everything completed
- The grant requires that the hazmat incident involve pipelines, whether it is gas or another chemical traversing through a pipeline; will look at options and might be in scope of work
- WEP pipelines are not considered hazardous material by DOT

A motion was made by Mr. Knapp, seconded by Mr. Ryan, to approve this item. Passed unanimously; MOTION CARRIED.

- Emergency Management is still waiting on the switch gear to be able to move; expected to ship this month, so moving by the first of the year
- 2. COUNTY CLERK: Chris Plochocki, Deputy County Clerk
 - a. Mortgage Tax Apportionment
- April September of this year; total apportionment is \$5,124,834.04
- Down 1% from previous report; down 22% from same period last year, but still looking at historically high numbers

A motion was made by Mr. Knapp, seconded by Mr. Burtis, to approve this item. Passed unanimously; MOTION CARRIED.

- **3. FINANCE:** Don Weber, Director of Real Property Tax
 - a. Denying the Application for Correction of Certain Errors on Tax Bills
- First time having a denial; property owners believe their parcels were taxed incorrectly and Real Property disagrees
- First parcel is a restaurant that was assessed lower this year; because of this the owner felt it was over assessed for previous years, which is not how it works

• Salina parcel is property owner that argued to be included in the town trash district when it was created, but now does not want to pay for trash; town is saying that this property is in the district and has to pay

A motion was made by Mr. Knapp, seconded by Mr. Burtis, to approve this item. Passed unanimously; MOTION CARRIED.

- b. Approving and Directing the Correction of Certain Errors on Tax Bills
- Tax bills recommending to approve over \$2,500; all legitimate errors to be corrected

A motion was made by Ms. Abbott, seconded by Mr. Knapp, to approve this item. Passed unanimously; MOTION CARRIED.

- c. Delegation of Authority to Approve Corrections to Tax Bills Resulting in Refunds or Credits Not Exceeding \$2,500
- Annual resolution that gives CFO authority to approve tax corrections under \$2,500; otherwise have to come to Legislature for approval
- Every month there is a report filed with the Legislature for these

A motion was made by Mr. Knapp, seconded by Mr. Burtis, to approve this item. Passed unanimously; MOTION CARRIED.
