### ENVIRONMENTAL PROTECTION COMMITTEE MINUTES – APRIL 18, 2023 JULIE ABBOTT, CHAIR

MEMBERS PRESENT: Ms. Cody, Mr. McCarron, Mr. Garland MEMBERS ABSENT: Ms. Kuhn ALSO PRESENT: see attached list

Chair Abbott called the meeting to order at 1:34 p.m. *The minutes of the previous meeting had been distributed, and there were no objections to waiving the reading. There were no corrections to the minutes, and the minutes were approved.* 

- 1. WATER ENVIRONMENT PROTECTION: Shannon Harty, Commissioner
  - a. A Resolution Calling a Public Hearing in Connection with Proposed Improvements for the Onondaga County Sanitary District (Ley Creek/Liverpool; June 6, 2023 at 12:55 p.m.)
- Off cycle funding request

### FYI to Mr. McCarron

- All of WEP's Capital Improvement Projects are bundled and part of the budget approval process
  - Projects are reviewed under CIP in October
  - Supported bond resolutions go to public hearing, then project Authorization Resolutions are done
  - Bond resolution authorizations happen sometime in December, January or February
  - These are off cycle asks due to size of projects
    - Did not have engineering done to lock in a construction cost estimate to keep in normal cycle
    - Asking for off cycle because do not want to wait till October; would like to advance construction this year
    - The first step of Funding Authorization process is adopting the resolution to schedule a public hearing
    - Everything WEP does that is associated with Capital Projects is subject to a public hearing
    - Different than everyone else because of standalone fund; Article 12, special district laws are followed

### Ms. Harty Addressed Committee

- First project is Liverpool and Ley Creek Force Main:
  - Two force mains
    - One comes from village of Liverpool (down Onondaga Lake Parkway, across Destiny to Metro Facility)
    - Ley Creek Force Main comes from Ley Creek Pump Station by the transfer station
    - Both come from consent order several years ago; experienced sizeable breaks/leaks
    - Need complete rehabilitation/replacement
- Seeking funding; doing in phases; let out in Phase 1
  - Contract 1: Majority will be in Liverpool Force Main from pump station in the Village of Liverpool to Destiny
  - $\circ$   $\,$  Contract 2: Ley Creek Pump Station will be in phase 2 from pump station to Destiny  $\,$
  - Bonding estimated for first phase at \$20M (awarded \$10M WQIP grant) for this project
- New phase 2 /Destiny, new bridge across canal
- **Questions/Comments from Committee**
- \$10M in addition, so \$30M project?
  - No, it will be a credit against that; Legislature authorized total project cost, any grant becomes funding source
  - $\circ \quad \text{Applied for grant during 2022 CFA}$
  - It was written by WEP and received in the fall

- b. A Resolution Calling a Public Hearing in Connection with Proposed Improvements for the Onondaga County Sanitary District (Metro WWTP; June 6, 2023 at 12:57 p.m.)
- Next phase of construction at Metro main plant was built in the 30's/40's, big upgrade in 1978
  Equipment is now 40 plus years old
- Multiple phases of Metro 78 annex asset renewal phase 1
  - Addressing all of the primary and secondary clarifiers
  - Estimated project cost \$69M
  - o Bond resolution this summer; advertising this project for construction fall 2023

### **Questions and Comments from Committee:**

- The cost of \$69M, is this a low estimate?
  - Number is on the conservative side; a little high
  - Do not want to advertise and not have funding to award it
  - Bid two larger construction projects, all coming in under what was estimated
  - o Back in 2022 when supply issues were high; starting to see market settle and prices coming down
  - Asking for conservative estimate to go forward

# A motion was made by Ms. Cody, seconded by Mr. McCarron, to approve item 1a. Passed unanimously; MOTION CARRIED.

## A motion was made by Mr. Garland, seconded by Ms. Cody, to approve item 1b. Passed unanimously; MOTION CARRIED.

### **Questions and Comments from Committee:**

• What is going on with Micron?

- WEP has been working with Micron since November/December
  - Working through initial utility services; establishing what capacity/timing needs will be
  - Taking longer than thought, but close
  - Have phased approach for initial municipal service by end of 2024 using existing wastewater treatment plant
  - Need sewer service for entire area along 31 corridor, Caughdenoy Road; authorization received
  - Still hammering out details (size/capacity/location of infrastructure)
- Is 2024 when project will be starting or having it ready?
  - 2 separate projects:
    - Municipal Sewer service (WEP Project) Expanding sewer service for entire community
    - Secondary Services (Industrial Phase) will follow along a parallel path; environmental reviews
- How is WEP's staffing?
  - Hired 60 people; comes with challenges; learning curve, training, retirements, young management team
  - o Going through organizational, cultural changes; with that comes confusion; working through it
  - People want to come and work for us; thanks to the Legislature for securing new vehicles, WEP has a healthy budget and tools, etc.
- Does WEP work with the union and contracts?
  - No, that is a whole other administration level

A motion was made by Mr. McCarron, seconded by Mr. Garland, to adjourn the meeting. Passed unanimously; MOTION CARRIED
