PUBLIC SAFETY COMMITTEE MINUTES – SEPTEMBER 10, 2024 **MARK A. OLSON, CHAIR**

Chair Olson called the meeting to order at 9:00 a.m., and the previous meeting's minutes were approved.

1. **SHERIFF:** Lisa Dell, Chief, Civil Department

a. Authorizing the County Executive to Enter into a Lease Agreement With the Town of Salina

- Have been in town of Salina space for over 30 years with no agreement
- Entering into lease agreement at a cost of \$1.00/year
- Plan on putting SRO's (School Resource Officers) in there
 - Community Relations Division
 - Project LifeSaver

Questions/Comments from the committee:

- Is this just for the town of Salina jurisdiction, or will the Sheriff's reach out to others?
 - Divisions within Sheriff's office stationed there (not patrolling)
 - School Resources will have desks there, an office, and park cars there
 - Losing space at headquarters and no parking downtown
 - Sheriff wants to continue to lease this space due to previous unit that moved out
 - Some renovations were done
 - Special units will have offices there

A motion was made by Mr. McCarron, seconded by Mr. Bush, to approve this item. Passed unanimously; MOTION CARRIED.

b. Authorizing an Intermunicipal Agreement With the Syracuse City School District for Librarian Services at the Onondaga County Justice Center

- This is for a part-time Librarian - services that have been in the Justice Center for a while
 - Librarian teaches high school equivalency program
 - Librarian provides Law library research for incarcerated individuals when books are needed or documents not at Justice Center (located on 5th floor of Courthouse)
 - Maintain a regular Library and rotate books
 - Books are donated by Jail Ministries, Catholic Charities and Other organizations

A motion was made by Mr. McCarron to approve this item.

- Law
 - No budget impact
 - Technically it is with another school district, so it is an IMA

Mr. Bush seconded the motion. Passed unanimously; MOTION CARRIED.

The meeting was adjourned at 9:04 a.m.
