# Use this form to decide if it makes sense to do a SPOA application.

**SPOA Eligibility** pertains to adults, who have a serious persistent mental illness resulting in impairments; who are in need of supportive housing or non-Medicaid care coordination.

**Diagnostic Criteria:** DSM 5 psychiatric diagnosis, i.e. serious and persistent mental illness (SPMI) with disability. Examples:

- Major Depressive Disorder, recurrent, severe (not from substance use or medical condition)
- Bipolar I or II Disorder, severe, may be with rapid cycling or psychotic features •
- Schizophrenia Spectrum Disorder (Schizophrenia, Schizoaffective) and Psychotic Disorders (not from substance use)

(Not eligible: Disorders due to alcohol/drug use, dementia, organic brain syndromes, developmental disabilities, neurocognitive disorders, general medical conditions or social conditions)

Diagnosis: DSM 5 code:

Disability criteria: Individual has a serious mental illness (SMI) resulting in functional impairments/disability which seriously interfere with the ability to function independently for an extended period (at least 1 year.)

#### 1. High priority criteria for OMH (Mental Health) licensed or supported housing; one or more of the following:

- Currently inpatient in a state psychiatric facility\*
- Two or more psychiatric hospital admissions within the last 12 months

AOT Order or AOT enhanced services\*

- Resident of OMH residential licensed housing
- ER visits for psychiatric reasons in the last 12 months

Meets SPMI criteria and is frequently presenting for services (ER's, correctional facilities, shelters, detox or rehab inpatient treatment) with high Medicaid costs
\*Note: Applicants from AOT and Hutchings Psychiatric Center have highest priority

### 2. Meets criteria for OMH (Mental Health) licensed residential programs

Has a diagnosed serious mental illness and one or more of the following:

Supplemental Security Income or Social Security Disability related to a diagnosed mental illness or

- Extended impairment in functioning due to a designated mental illness or
- Reliance on psychiatric treatment, rehabilitation and supports
- Physician has determined necessity for Restorative Services; applicant meets Medicaid Medical Necessity criteria
- 3. Meets basic criteria for **non-Medicaid Care Management (NMCM):** Serious psychiatric disorder **AND** functional impairments (in ADLs, personal safety, community living, self-sufficiency, use/engagement with medical or mental health services, housing vulnerability)

# If yes on sections 1, 2 and/or 3; complete the SPOA application to apply for these programs:

NMCM (non-Medicaid Care Management) OMH residential programs (licensed housing or SRO's) OMH supported housing programs (for OMH high priority only)

#### **Reminder of system changes:**
