Onondaga County Annual Open Enrollment Period For the Addition of Viable Agricultural Land to a State Certified Agricultural District January 1, 2025 through January 30, 2025

New York State Agricultural Districts are intended to encourage the continued use of farmland for agricultural production. Enrollment of viable agricultural land into a State Certified Agricultural District provides protection of accepted agricultural practices through New York State Agricultural Districts Law. Viable agricultural land is highly suitable for a farm operation as defined by NYS Agriculture & Markets Law.

Property owners can request that their property be added to an Agricultural District in Onondaga County between January 1 and January 30 of each year. Owners must complete the attached Request Form and return it **NO LATER THAN JANUARY 30, 2025** to:

The Onondaga County Agriculture & Farmland Protection Board (AFPB) will make recommendations on requested additions to the Onondaga County Legislature for their consideration at a public hearing, and, if accepted, Districts with additions will then need to be certified by the New York State Department of Agriculture & Markets. Landowners requesting the addition of viable agricultural land will be notified of the County Legislature public hearing and the New York State Department of Agriculture & Markets district certification.
