

NOTICE OF A PUBLIC HEARING ON RENEWAL OF AGRICULTURAL DISTRICT NO. 3,  
COUNTY OF ONONDAGA, TOWNS OF CAMILLUS, CICERO, CLAY, ELBRIDGE, LYSANDER,  
MANLIUS, AND VAN BUREN

NOTICE IS HEREBY GIVEN, that a public hearing will be held by the Onondaga County Legislature on the renewal of Agricultural District No. 3. The hearing will be held at the Onondaga County Courthouse, County Legislative Chambers, 4<sup>th</sup> Floor, 401 Montgomery St., Syracuse, New York on Tuesday July 5, 2022 at 12:50 p.m.

Pursuant to Section 303-a of Article 25AA of the New York State Agriculture and Markets Law, the Onondaga County Legislature adopted Resolution No. 156-2019 providing for notice of the eight-year review of Agricultural District No. 2 in the Towns of Camillus, Cicero, Clay, Elbridge, Lysander, Manlius and Van Buren.

The Onondaga County Agriculture and Farmland Protection Board has prepared a report in accordance with the provisions of Article 25AA, with recommendations to continue such district with modifications.

The lands proposed to be added are parcel 022.-02-42.0 in the Town of Camillus; parcel 080.-02-10.0 in the Town of Cicero; parcels 028.-01-39.0 and 028.-02-25.1 in the Town of Elbridge; parcels 015.-05-04.1 and 026.-03-13.1 in the Town of Lysander; and parcels 099.-02-06.7, 116.-01-06.3, 116.-01-08.1, 116.-01-08.2, 116.-01-08.4, and 117.-03-02.0 in the Town of Manlius.

The lands proposed to be removed are parcel 006.1-02-04.0 in the Town of Camillus; parcel 042.-02-13.1 in the Town of Elbridge; parcels 049.-03-03.3, 064.-03-03.1, 071.-02-47.3, 073.1.-01-28.4, 073.1.-01-06.0 and 073.1.-07-08.0 in the Town of Lysander; parcels 091.-02-12.0, 091.-02-14.0 and 100.-02-03.3 in the Town of Manlius; and parcels 131.8.-01-03.0, 131.8.-01-04.0, 131.8.-01-17.0, 131.8.-01-20.0, 131.8.-02-02.2, 131.8.-03-03.0, 032.-02-01.0 and 044.-02-09.2 in the Town of Van Buren.

These proposed changes will be considered at the public hearing.
